Dear Colleague Members,

**W**ishing You a Very Happy and Prosperous 2022, a "Year of Hope".

The beginning of the year is usually a time for reflection and goal-setting – but after a challenging, stagnant 2021, many of us are struggling with motivation.

Let's be positive and let TAAI be your motivator!

The Travel, Tourism and Hospitality Sector under which all of us sync has survived the worst. Given the importance of travellers to India's social and economic fabric, the sector's slower recovery relative to other sectors throughout the pandemic, and the impact of current and potential future coronavirus variants, creative approaches should be considered for the sector to emerge stronger.

**We propose three areas to consider:**

1. Focusing efforts on encouraging domestic travellers to visit—and revisit—each destination; reinvigorating the workforce to enhance visitors' experiences; and reimagining India as a hub for business travel by keeping up to date with changing working norms.
2. Approaches to entice domestic travellers include doubling down on offering must-attend, extraordinary events. Encouraging visitors to extend their stays to explore undiscovered parts of Incredible India, and harnessing digitization to elevate visitor experiences with smart-city (or technologically modern) concepts. Some destinations have given their iconic landmarks an artistic twist, so that even return visitors can encounter a familiar monument, with fresh eyes. This should be planned and updated in our itineraries. Your Association, TAAI has proposed to India Tourism as well as State Tourism's to partner with us and educate our members on such developments. We shall also be undertaking registration drives along with MoT as State Tourism for our members to take advantage of the MDA's offered by the Government to accredited agents.
3. Reinvigorate the travel workforce: Friends, we all have curtailed our expenses by taking pay cuts! With every surge in business, we get excited and are desirous to spend. We Must! However, we must ensure that we do not fix our employment costs. Rather than increasing salaries, we must look into incentivising sales and profits. This shall keep our fixed costs under check.

Exacerbated by widespread labour shortages across industries, a diminished workforce could see the travel and hospitality industry short-staffed and lacking the capacity to deliver indelible memories to visitors. Tourism growth would also likely be inhibited.

Our industry is forever evolving as we have to stay abreast with information not only on a continuous basis but nowadays on a daily basis.

We have already commenced training for our members for NDC along with the GDS and more detailed schedules are being planned. Further, along with professional training institutions, we shall be undertaking professional, practical training programs and keeping our members and their teams upskilled and educated on developments to enhance business.

Let us all wish and pray for the virus impact to recede and a New Hope for 2022 to vitalise our industry. Let us be cautious and follow all protocols set by the Government. Our care shall protect our Nation and help all of us prosper and grow in the year ahead.

# What Next?

The pandemic has had the worst impact on many families & business around the world. Within industries, the travel industry and within that the offline travel intermediaries have been most severely affected.

As a result of the pandemic over the past 22 months, the world has also changed on parameters of commerce. Some trends are emerging which may impact the travel business more than the others..

- Digitisation may continue to influence the way transactions happen between buyers & sellers and will also impact the way businesses are run internally between their suppliers, their employees and their bankers.
- Companies across industries will be lesser city centric as their employees will work from their homes, which may impact both the FIT corporate travel patterns and the MICE movements for the foreseeable period.
- Newer domestic and short haul tourism destinations will emerge based around the concept of nature and wellness travel.
- Shorter and more frequent trips may be planned around holidays and bookings may have shorter lead times considering uncertainties around any outbreaks.
- Travel advisors may be looked upon as complete solution providers whenever there are multi-point, multi-experience journeys.
- Alternate accommodation may continue to be eagerly sought more so in emerging getaways and for options around staycations & workcations.

Nature, provides the most remarkable instance of transformation of a butterfly which goes through three stages before reaching its most ideal stage. Travel advisors too will have to transform themselves around the way their consumer behaviour is emerging. Some of the key adaptations which may be required to the 'travel business models' could be the following.

- Include higher component of verified 'Alternate accommodation' options across destinations in one's product inventory.
- Continually offer new destinations both within country, short-haul international and medium haul international.
- Digitise as much possible for enabling customer ease, in terms of booking, in-trip management and post-trip follow ups.
- Link up alliances across key markets and complimentary travel segments with other like-minded travel advisors to

- offer customers, seamless and specialised solutions
- Include the facility of multiple digital payment options across cards, net banking mobile & unified payments.
- Identify, map and offer inventory of multiple experiences across accommodation, dining, shopping and entertainment across as many destinations as possible.
- Be ready to offer service guarantees and offer quick redressal of grievances to develop happy customers.
- Keep in touch with customers in a non-intrusive manner and be alert to cross-sell to customers on any travel opportunities whether in their families or within their companies.

As most people have not travelled over the past 22 months, it is expected that travel industry will be the biggest gainer post the pandemic and may have the biggest share of consumer spends both by consumers and by corporates.

This pandemic is affecting most offline travel advisors. But those who have and those who continue to utilise this harsh & forced hibernation to redesign their organisation and to restructure their strategies, may be more ready to seize opportunities on the other side of the pandemic as and when that happens. ▲

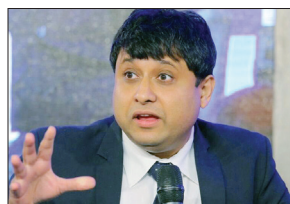
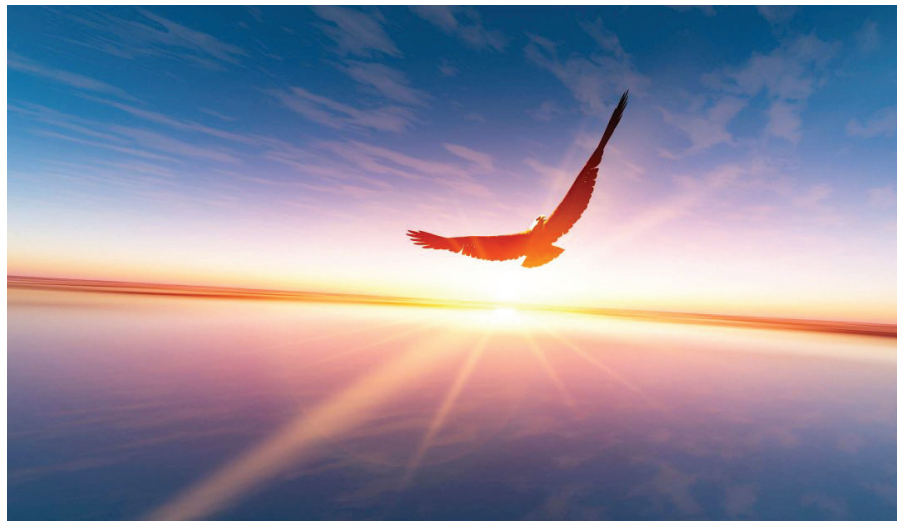

"We are ready to welcome all age groups at special

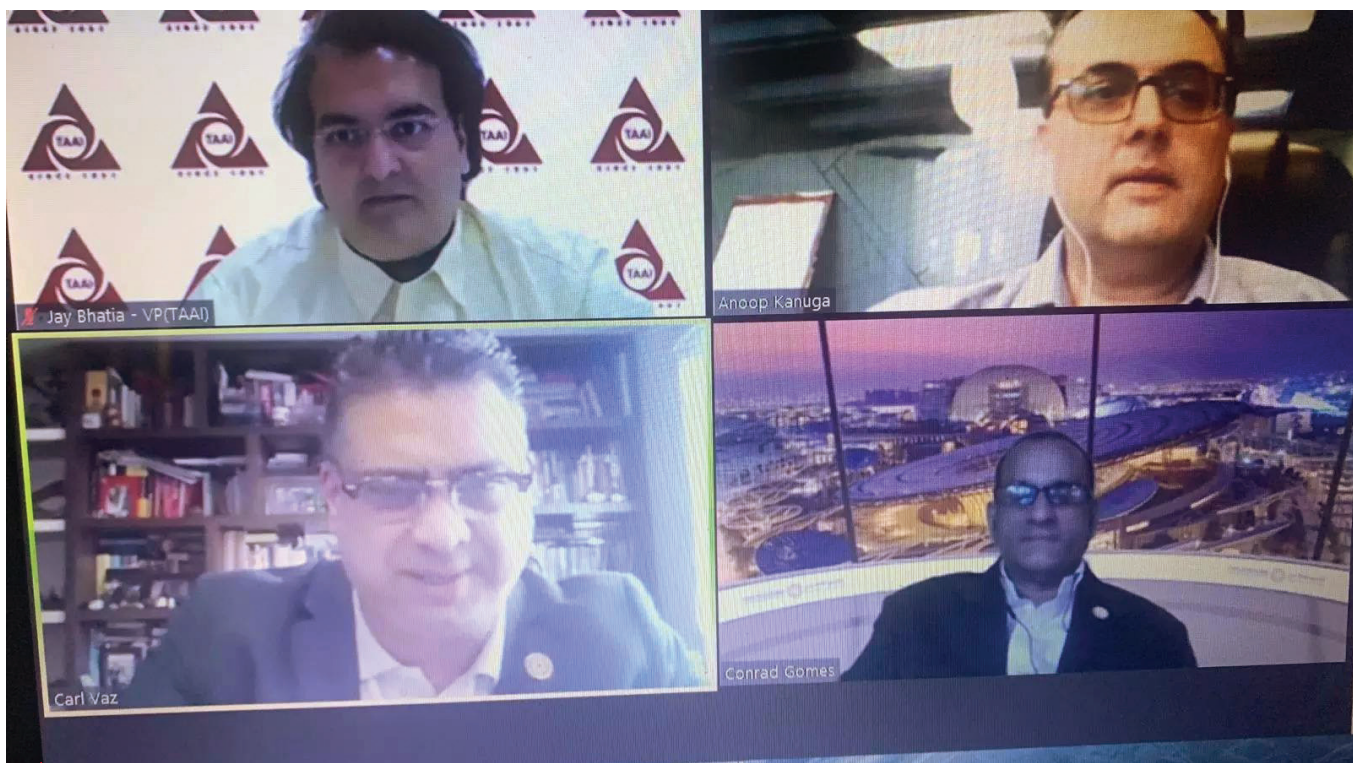
pricing and are happy to partner with TAAI as one of the key associations in India," stated Vaz on the partnership with TAAI for Dubai Expo 2020.

## Create infrastructure & facilities beyond hotels and resorts for MICE Tourism: TAAI Vice President Jay Bhatia

TAAI Vice President Mr. Jay Bhatia was one of the keynote speakers at the webinar organised on October 6, by the Consulate of Sri Lanka in Mumbai in collaboration with the Sri Lanka Convention Bureau on preparing Sri Lanka MICE ready, by 2022.

Delivering the keynote address during a webinar organised to promote MICE tourism between India and Sri Lanka, Mr. Bhatia said that MICE events could be curated around festivals and events like sports or adventure activities in both nations.

He emphasised on the need to create infrastructure and facilities beyond hotels and resorts. He said, "Monuments, theme parks, forts like Sigiriya or even Fisherman's village could be explored as locations for incentives and events. MICE events

could be curated around festivals and events like sports or adventure activities." He also requested Sri Lankan airlines to come out with special MICE airfares, wherein travellers visiting for the same event from different parts of India could get beneficial group fares.

He mentioned that TAAI and the Sri Lanka Association of Inbound Tour Operators (SLAITO) have recently signed a tourism promotion MoU and MICE events too must be promoted along with pre and post tours in Sri Lanka, which shall boost tourism as well as the local economy.

In line with MoU, the TAAI VP thanked the Consulate General in Mumbai and stakeholder partners in Sri Lanka with whom wonderful progress in boosting travel from India can be maintained. ▲



## TAAI Welcomes Ministry of Home Affairs' Move to Re-start Tourist-Visa

TAAI welcomed the Ministry of Home Affairs (MHA) decision to re-start tourist visas for foreign travellers coming to India on chartered flights from October 15th. TAAI, India's largest and nodal travel trade association, has requested its members across its 20 regions and chapters, to ensure they update all incoming visitors on protocols set by the state governments where the passengers will be travelling to.

Commending the move, Ms. Jyoti Mayal, President, TAAI said they welcome the move as a date has finally been given by the government to resume inbound travel and they are happy to acknowledge the announcement of the resumption of Tourist Visa to foreigners coming to India on charter flights from 15th October & further for others effective 15th November 2021. "We hope commercial flights will start beyond air bubbles effective 15th November to facilitate seamless travel. TAAI along with FAITH have submitted numerous representations requesting the Ministry of Civil Aviation, Tourism, Health and External Affairs on the subject. Our results have now finally yielded some relief & members can start planning." She also added that the government has decided to opt for 'reciprocal treatment' to the applicants under new visa conditions. As per reports, the visa facilitation will now depend on the applicant's home country's policy for the

Indian tourists.

"We are pleased to note that Indian borders are opening & inbound travel will see light soon. This will be a great relief to the travel trade fraternity of India as the business will surely pick up & after a long gap our members will be able to transact more business. season is coming, and a decision like such has created a negative sentiment in the industry as well as for a traveller," she said.

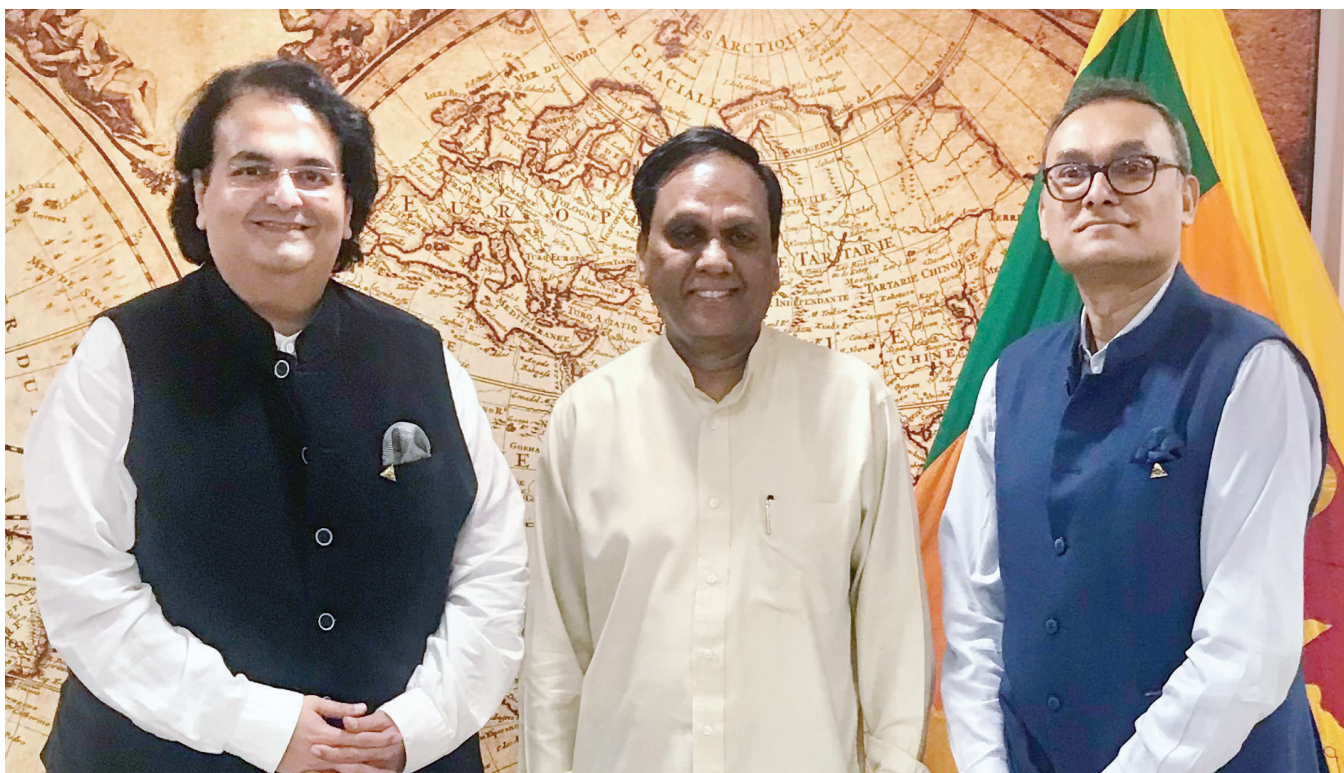
She further stated, "Intimation would have given a chance to the fraternity to be ready and inform their customers accordingly. However, now we have to face the heat and bear the brunt of limited or no travel and perhaps cancellations. We would urge the authorities and the government to work in tandem with the travel trade and intimate well in advance of any such orders and decisions."

A number of airlines have also requested the government, both civil aviation and defence authorities, to defer the airport closure in the peak festive season. Currently, 55 flights are operational from the Pune airport. From October 16 to October 29, all flights from the airport have been cancelled. ▲

# TAAI shares recommendations on MoCA's Heli-Tourism policy pitches for better infrastructure



The Travel Agents Association of India (TAAI) represented the travel trade fraternity at a virtual meeting convened by the Ministry of Tourism to discuss and deliberate upon the Ministry of Civil Aviation (MoCA)'s draft 'Heli-Tourism Policy'.

During the course of discussions, recommendations suggested by TAAI were taken up by Mr. Paras Lakhia, Managing Committee Member and Chairman, Airlines Council in the meeting chaired by Ms. Rupinder Brar, Additional Director General (ADG), MoT. The suggestions included inviting private players to foray into the vertical of heli tourism and emphasis was given on the need of developing heli infrastructure at the same pace as developing airports & seaports.

The suggestions by TAAI mentioned that all-important hill stations & religious destinations especially where road journey is tedious, but are well visited and popular, should be facilitated with heli service from its nearest airport or seaport. Destinations and routes such as Hampi, Coorg, Kevadia, Munnar, Goa, Udaipur to Nathdwara, Delhi to Agra, Bangalore to Mysore, Srinagar to Gulmarg etc. can be developed for heli tourism.

Mr. Lakhia opined that heli business may pick up fast if aerial tours at tourist destinations are started on priority so that travellers and visitors may see the entire place in a limited time. 'Heli services could also come as much-awaited relief to the remotest parts of our country with no or fewer medical facilities,' he added.

Jyoti Mayal, President, TAAI commenting on heli tourism said, "We are happy that the MoT & MoCA are creating more avenues & investing in infrastructure. Heli tourism has tremendous potential and because of that more impetus and boost should be given by the Government looking into ease of business for travel agents. Selling of inventory should be only through recognised agents/tour operators. Also, all correct procedures & standard policies for refunds, cancellation, financial security, insurance on travel protecting the consumer from helicopter companies on defaults, GST credit, payment through credit cards etc. need to be adopted before the start of the project."

She also added that providing subsidies on capital investment and parking charges for helicopters could be a welcome move to invite private investments. ▲

# TAAI supports 'reciprocity' in international travel; seeks more clarity on procedures



While supporting the spirit of reciprocity contained in the guidelines published by the Ministry of Health & Family Welfare, Government of India, for international arrivals as the country prepares the ground for reopening of international borders from November 15, TAAI sought more "clarity in procedures" to make it easily understandable to travellers and travel industry stakeholders

In a statement, Ms. Jyoti Mayal, President, TAAI appreciated the government's decision for initiating and implementing reciprocal treatment. "With flights opening up next month in a limited manner, we need to have standardised protocols in place across the country and more clarity on procedures. Also, the government should request partner countries offering air bubble arrangements to follow the same protocols. For instance, if a traveller is coming from the US or UK and transiting through Dubai then protocols of the country from which the flight has originated should be taken into consideration," said Ms. Mayal.

She appealed to the government to open commercial flights fully, at least with countries that recognise and accept vaccinations approved by the Indian government. "We believe that it will be a welcome move and can help businesses to revive, both aviation and tourism, at a much faster pace."

The travel and tourism industry has pointed out some ambiguities in the guidelines issued by the government, which were effective from 25th Oct.

Understanding the aspect of reciprocity, the government guidelines allow countries that have agreements with India and recognise Indian vaccine certificates or recognised by WHO and allow Indian visitors quarantine-free entry will have easy procedures while entering India compared to citizens of other countries.

Fully vaccinated citizens of the category 'A' countries with which India has either mutual agreement or recognise the Indian vaccine certificate and allow quarantine free entry, can leave the airport on arrival straightaway. In case they are partially vaccinated, they can leave the terminal after submitting the RT-PCR sample on arrival. They have to do home quarantine for 7 days before undergoing a second test on the 8th day.

However, all travellers, irrespective of their vaccine status, have to carry and produce a negative RT-PCR certificate obtained within 72 hours of arrival in India.

All international travellers also have to fill in an online self-declaration on the 'Air Suvidha' portal and also upload the RT-PCR negative certificate before boarding the flight. They also have to give a self-declaration on the authenticity of the report. ▲

# TAAI shares inputs on promoting rail tourism with government through PPP model; pushes for better coordination with travel trade



In a virtual meeting with the Ministry of Tourism, Government of India, TAAI shared its inputs with the government on giving impetus to rail tourism in India. Mr. Bettaiah Lokesh, Honorary Secretary General, TAAI and Anoop Kanuga, Chairman -Tourism Services Council & Managing Committee Member narrated on how rail tourism products can be promoted in the country with the help and support of travel trade. The virtual meeting was conducted October 15.

The 2nd meeting on the same day was chaired by the

Union Railways Minister at Rail Bhawan, New Delhi Among various suggestions, TAAI laid emphasis on travel agents and tour operators working very closely with the government to promote rail products and how they should be mandatorily commissionable to them. "This is a potentially fantastic rail-tourism product. This should certainly create an initial impetus for private capital to participate in public services to create incredible stories around Indian Tourism," TAAI mentioned. ▲

# Air bubble travel has reached its threshold limit, government should resume scheduled commercial international flights at the earliest: TAAI



Jyoti Mayal, President, Travel Agents Association of India (TAAI) said that air bubble agreements, which has been a crucial tool to keep international travel on, has reached their threshold limit and the government should quickly take a decision of restarting regular commercial flights.

With reports of the government getting requests for revising the 'air travel bubble' policy, the travel trade has also sharply reacted on the matter and demanded the restoration of scheduled commercial international flights to keep in check increasing airfares and safeguard the interests of travellers and tour operators. Sharing her thoughts, Jyoti Mayal, President, Travel Agents Association of India (TAAI) said that air bubble agreements, which have been a crucial tool to keep international travel on, has reached its threshold limit and the government should ponder upon restarting regular flights soon.

"A move initiated by several governments during COVID times was welcomed by the travel trade as it was need of the hour to curb the spread of the pandemic,

however, with airfares soaring and limited airlines operating internationally it is time for governments to relook into it and either revoke or add more flights on the busiest routes. India needs to revive footfalls into India and utilise the 5 lakh free visas for inbound travel by March 2022. Unless flights restart this would be difficult to achieve & only resumption of flights will support the Indian tourism and travel sector to revive and re-establish their business," she added.

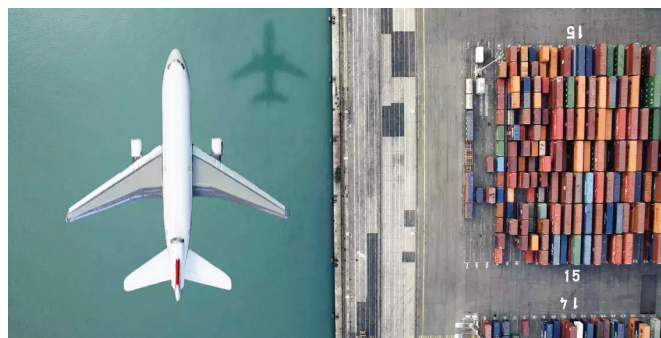
On the matter, Jay Bhatia, Vice President, TAAI stated, "An agreement signed and agreed upon to facilitate travel is now the major hurdle and hampering the businesses. The travel trade has seen bad days and the sector was grossly damaged, however, we kept our hopes high. And now, when we are going back to normal, an agreement like such is gradually becoming a roadblock."

Notably, the government had suspended all scheduled international flights on 22nd March 2020 in the wake of the COVID pandemic. ▲

# Government should formulate a concrete roadmap for Export Incentive Scheme: TAAI President

# Quarantine free entry of foreign travellers from 99 countries is a ray of hope to foster travel trade & economy amid this global pandemic: TAAI



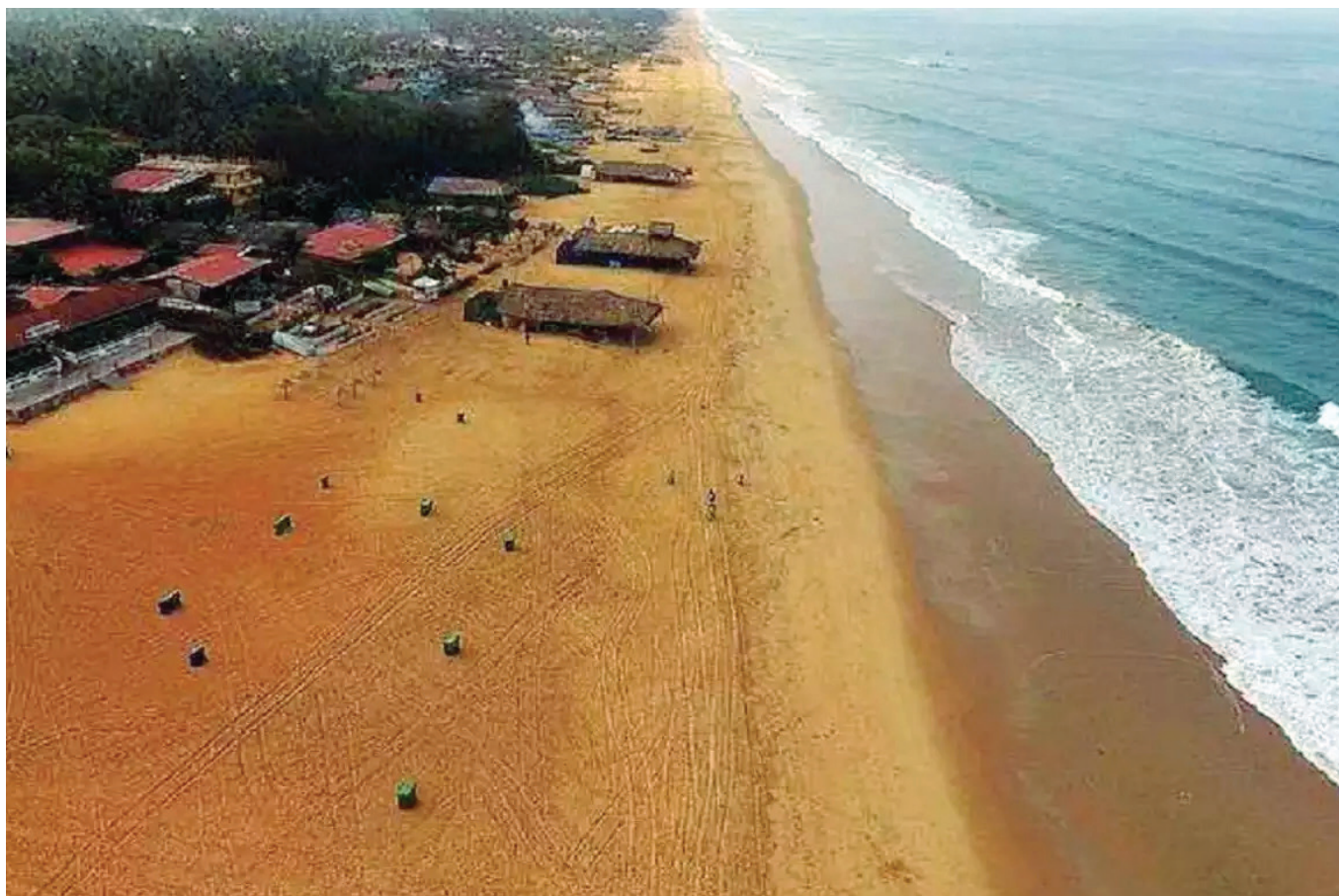

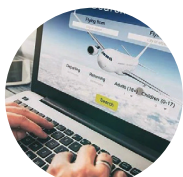

# TAAI appealed to Maharashtra Govt. to synchronise new COVID protocols with Central Govt.



**T**ravel Agents Association of India (TAAI) in its communication dated December 1 to Shri Aditya Thackeray, Minister of Tourism, Govt. of Maharashtra had appealed to synchronise the new COVID protocols, for domestic and international travellers, coming to Maharashtra, in line with the directive of the Central Government.

These guidelines for Maharashtra were issued by the Chief Secretary on 30th November'21, marking it mandatory for all travellers to carry an RT-PCR test report 48 hours before departure, before entering Maharashtra, irrespective of being dually vaccinated.

As regards international travel, it was mandatory for all arriving passengers from At-Risk Countries (as per GOI list) to undertake institutional quarantine for 7 days, due to which there is likelihood that passengers will be re-routing through other states and cities out of Maharashtra and shall stay for a day obtain RT-PCR and then arrive into Maharashtra.

Highlighting the inconveniences which will be borne by arriving passengers and drastic effects on the badly hit travel industry, TAAI appealed that Maharashtra follows standard universal protocols in sync with the Central Government for International as well as Domestic travellers arriving into the state.

Maharashtra Govt amended the travel rules for international and domestic passengers, to align its policies with that of the Central Government.

Welcoming this decision, Jyoti Mayal, President, TAAI, said "At such times, when economic revival is the need of the hour, the decision brings so much relief. Now no RT-PCR test is required for fully vaccinated domestic flyers travelling to Maharashtra. Negative RT-PCR test report not older than 72 hours of departure would only be required for those who are partially vaccinated or unvaccinated."

"All states should have collaborated policies. We are one country and need one set of rules and regulations for the travel & tourism industry. With different policies, what will be the difference between international & domestic borders? TAAI has been advocating that we need coordinated policies globally for crossing international borders," she added.

"The state government has also narrowed down the list of inbound arrivals who need to undergo institutional quarantine from 12 to three ultra-high-risk countries – South Africa, Botswana and Zimbabwe" commented Jay Bhatia, Vice president, TAAI.

Bettaiah Lokesh, HSG, TAAI added that such rule alteration will certainly provide some relief in these catastrophic times of business turmoil.

"This will further put a filter and a right check on the passengers who are entering the state to prevent the spread of pandemic and to refrain from another deadly wave or lockdown," said Shreeram Patel, Hon. Treasurer, TAAI. ▲

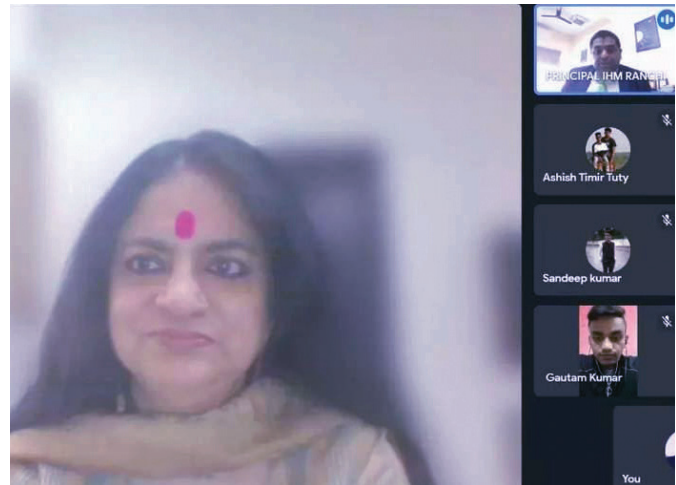



# Patience is a virtue on the road to recovery: Jyoti Mayal during interaction with students of IHM Ranchi

The Government of India has an agreement for mutual recognition of vaccination certificates with over 100 nations for individuals fully vaccinated with nationally recognised or WHO recognised Covid-19 vaccine and those exempting Indian citizens fully vaccinated with nationally recognised or WHO recognised vaccines. ▲

# Compulsion of Air Suvidha for incoming international arrivals is a good step to further prevent the catastrophe: Jyoti Mayal

Ministry of Civil Aviation and Ministry of Health & Family welfare have made it mandatory for all international passengers arriving in India to declare their current health status prior to boarding on the Air Suvidha Portal. The exemption forms from the Air Suvidha Portal have been discontinued, and filling of the details have been made compulsory for all international arrivals in India.

Commenting on this, Jyoti Mayal, President, TAAI said, "Air Suvidha is first of its kind 'digital portal for easing international passenger arrival in India; developed by MoCA which aids passengers in providing their details of travel and final stay along with RTPCR, vaccination status. Therefore, making it mandatory for incoming international arrivals is definitely a good step to further prevent the catastrophe.

"Updates like segregation of passengers from at risk countries to normal countries by singling them out with a red band and marking with 'H' while associating the green colour with the latter, keeping a tap on passengers journey in the last 14 days, updating the FAQ list are some of the 'in time' decisions which might bring down the risk of virus spread," pointed out Jay Bhatia, Vice President, TAAI.

There also have been changes made to the list of passengers arriving/transiting from countries at risk, "Submitting self -declaration form on the portal, uploading



RTPCR status, self -quarantining for seven days and retesting on the eight day are necessary requirements in the way to avoid shutting down of newly opened tourism sector after a long halt" commented Bettaiah Lokesh, HSG, TAAI.

Shreeram Patel, Treasurer, TAAI also supported the government's decisions of making such process mandatory in view of rising corona virus and said that this would somewhere benefit the travel trade and people in general. ▲

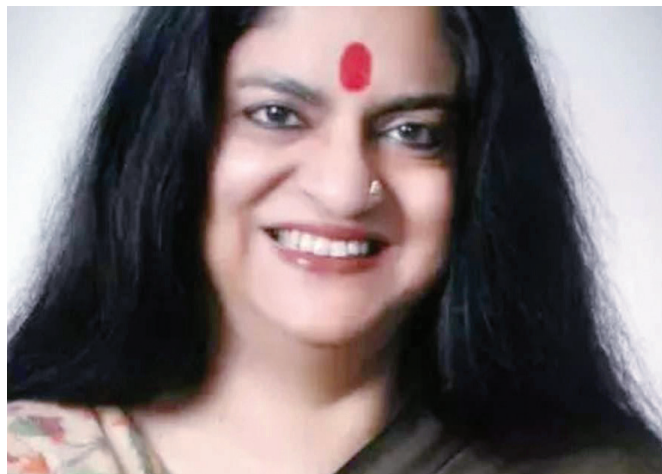
## Sri Lanka MICE Expo 2021 organises “Virtual Business Forum for Incentive Organizers” on December 2

# A long wait is finally over as the Bengal-Sikkim rail project picks up pace: TAAI

The work on rail connectivity from West Bengal to Sikkim has made quick progress after Prime Minister Shri Narendra Modi ticked off officials from Railways and the West Bengal government early this year. The government has set December 2023 as the deadline for this crucial northeast connectivity project.

Extending her wishes and gratitude to the Prime Minister and the government of West Bengal, Jyoti Mayal, President, TAAI, said, "The wait was long but finally the destination has arrived after 10 years of wait. This will not only strengthen the boundaries but also foster tourism which is a need of the hour. Currently, Sikkim and Kalimpong districts are dependent solely on NH-10A from Siliguri which most often gets disrupted due to landslides, this project will ease out that burden and make a smooth passage for visitors."

Following the PM's push, approvals from the West Bengal government came fast and the pace of digging the tunnel has increased. "There has been an immense increase of more than three fold in the past six months from 300 meters a day to 1 km per day and it is likely to touch 1.3 km daily by December end," quoted Jay Bhatia, Vice President, TAAI.



Adding to it, Bettaiah Lokesh, Hon. Secretary-General, TAAI mentioned that such dedication and good speed will definitely prove to be beneficial for the accomplishment of such a huge project in the way of tourism. After getting necessary approvals from the West Bengal government and forest department in June 2019, activities at all the fronts were planned for executions.

Mentioning the pros of the project Shreeram Patel, Treasurer, TAAI said that it will provide all-weather connectivity to Sikkim. This will be a big boost for tourism in the region and has strategic significance for the defence of the country. ▲

# Extending international flight ban would further create chaos for the newly-opened tourism sector: TAAI

The Directorate General of Civil Aviation (DGCA) extended the suspension of international scheduled passenger flights till January 31, 2022, however international flights will continue to operate under the air bubble arrangement as the aviation authority clarified in a communication last week.

The decision to resume regular international flights from December 15 was put in abeyance in light of the evolving situation pertaining to the Omicron variant of Covid-19. While announcing the scrapping of the resumption, the DGCA had said that the effective date of resumption would be announced in due course.

Commenting on the decision, Jyoti Mayal, President, Travel Agents Association of India (TAAI) said, "Keeping in mind the economy structure and travel trade, this move may not prove to be a wise decision so to speak, things have just started to pick up and such restriction could hamper the functioning and delay the recovery."

While, Jay Bhatia, Vice President, TAAI commented that it is a good call from citizens' health's prospect but having said that further extension might prove to be an economic disaster.

Adding to it, Bettaiah Lokesh, HSG, TAAI mentioned that

these types of bans were imposed earlier also but unfortunately this couldn't refrain virus from spreading. To keep things under control without disturbing the economy much, the Government should ponder upon different ways apart from such restrictions," he said.

Scheduled international passenger flight services have been suspended since March 23, 2020, due to the Covid-19 pandemic but special international flights have been operating under the Vande Bharat Mission since May 2020 and under bilateral air bubble arrangement since July 2020.

"If the government has decided that the only way out to fight this pandemic is imposing international flight restrictions, then they should also work effectively on increasing the bilateral air bubble arrangements

with other various countries," stated Shreeram Patel, Treasurer TAAI.

India has signed air bubble pacts with 33 countries including the US, UK, UAE, Australia, and France which needs to be increased with immediate effect to balance out the losses that will occur with international flight ban extension, opined the TAAI team. ▲





## Job-oriented courses supported by MOT will boost youth's morale & write-off unemployment: TAAI

# Last-minute booking cancellations pose threat to already-fragile tourism recovery: TAAI

Concerns over the Omicron coronavirus variant and fresh travel restrictions have led to a spike in hotel and travel booking cancellations globally and have put an added pressure on the already fragile tourism industry. The Omicron outbreak has led to a flurry of new testing rules and border closings, raising concerns ahead of the important Christmas travel season.

Commenting on which Jyoti Mayal, President, Travel Agents Association of India (TAAI) said, "Cancellation rates have increased to 35 per cent since November 2021 and holiday travel planning was down to 10 per cent and most travellers were choosing domestic destinations. Multiple events ranging from sports and trade shows to corporate parties have been canceled, also leading to a slowdown in hotel bookings. Things could become hard to manage and recovery at this on- off pace would do no good to the revival, she also urged the government not to go for the previous same structure of overall shutdown."

Comparing the statistics with the previous financial years, Jay Bhatia, Vice President, TAAI said that overall activity around holiday travel planning has slowed down, growing by just four per cent since the variant was discovered. "By comparison, Christmas travel increased by 34.7 per cent in the same one-to-two-week period in 2019," he pointed out.

"Last month, there was a decent increase in the number of travellers and bookings which was taken as a good sign for



the tourism sector to replenish, but this new variant followed by changed guidelines and decrease in the travellers' traffic have altered the scenario and posed a serious threat on the already weakened industry," added Bettaiah Lokesh, HSG, TAAI.

While, Shreeram Patel, Treasurer, TAAI mentioned, "Uncertainty is all over the place, people are unsure what step to take next whether to plan a trip or spend the holiday season homebound. There is a sense of confusion, and it is now the role of the authorities to come into the picture and guide people about the possible situations that can arise and help them sail through." ▲

## Adopting Uttarakhand's homestays model can be considered to kickstart economy & boost business: TAAI

Appreciating the steps taken by the Uttarakhand government to promote homestays, Jyoti Mayal, President, Travel Agents Association of India (TAAI) has urged the Centre to consider the same model for other states as well while saying that 'such baby steps would prove to be fruitful in the time to come.'

"We have already seen the worst and speaking from the wise man's perspective, we all must know the survival amid COVID by now. We need to keep ourselves more than ready to go to any lengths if we want our tourism sector to flourish" Mayal commented.

who lost their jobs and bread winners in this pandemic are in dire need of money."

Bettaiah Lokesh, HSG, TAAI in his comments acknowledged the state government's move for engaging people and generating business and revenue. "The government is already providing self -employment through various schemes and has also simplified the process of loans; this homestay plan would not only provide bread to the locals but also boost tourism from travellers who like to enjoy local and comfortable places rather than luxury hotels."

"We all have seen a lot in the years gone by and are definitely ready if situations become fatal, but we cannot afford to let this pandemic be a hindrance in any way to our businesses. We as an industry stand strong and shall try our best to come up with ideas to keep the flow alive and we wholeheartedly support any good move like homestays that are directed towards strengthening the economy and boosting the travel sector," stated Shreeram Patel, Treasurer, TAAI. ▲



## TAAI participates in ETTravelWorld's Roundtable discussion on "Omicron and Travel Recovery: What to Expect" on 22nd Dec

After a gruesome 20 months of no or very little business, the Indian travel and tourism industry was slowly returning on the path of recovery. ETTravelWorld, saw discussion on the current scenario in the industry and what can be expected in the times to come. The panelists included Vipul Prakash, Chief Operating Officer, Make My Trip; Dipak Deva, Managing Director, Travel Corporation of India and Jyoti Mayal, President, Travel Agents Association of India (TAAI).

Discussing the hurdles the industry is facing in its road to recovery and are there any bright spots for 2022, the leaders said that the situation looks challenging with the way things are moving but there is light at the end of the tunnel. Ms. Mayal in her comments said even survival has become hard. "Things are challenging the way they are moving, new protocols every now and then are frustrating. The hurdle is more in our mind than actually it is, and I believe we will have to learn to live with Covid. We are taking baby steps currently and I strongly believe as I reiterate, we need to work together in a collaborative manner with more coordinated policies from the government," she said. ▲

### TAAI requests MOT to start state-wise registration drive, set up an Outbound Tourism Desk

TAAI, in its focus 2022 document presented to Shri Arvind Singh, Secretary, Ministry of Tourism highlighted that how the government's support and encouragement to tourism and help travel trade stabilise and sustain the challenges posed by COVID 19 pandemic. The association paid its gratitude and appreciated the ministry's efforts and support extended to the travel trade during the tough times.

Jyoti Mayal, President, TAAI highlighted the key issue of accreditation of members and travel agents with MOT and requested them for undertaking a state-wise registration drive along with TAAI, for the trade members to register with MOT. "We request to relax norms for over 1,400 IATA accredited agents, who are members of TAAI and automate the registration process," she said. She also took up the issue of setting up an Outbound Tourism Desk, which she said is urgently needed to support and regularise the operations for outbound travel from India.

She also brought up the issue with airport entry passes for tour operators and urged them to resume the services like before. "We urge you to ensure smooth handling of inbound/outbound and domestic special groups, children, seniors and other travellers, who require our hand-holding be permitted to apply for such permits, like before. Special arrival handling by

trade members for inbound and outbound tourists shall not only assist but also glorify Incredible India," she added.

Jay Bhatia, Vice President elaborated that TAAI wishes to commence certified educational programs for its members and the entire trade on Incredible India. "Training on NDC / GDS / visa rules, inbound, outbound, MICE organisers, education on financial matters, agro-tourism packages etc. are a few programs that could be designed by TAAI on the basis of the experience and expertise its members hold because of the understanding of the challenges and being part of the trade since many decades.

Bettaiah Lokesh, HSG, TAAI commented that the Indian travel trade faces a lot of challenges while promoting both inbound and outbound tourism, and competing in the global world, especially pertaining to the GST, TCS, Credit Control, Tax rebates, incentives, support and much more. Taxes like such need to be abolished or at least substantially reduced, to start with, so that our Indian travel trade can compete in both inbound and outbound market and generate a huge foreign exchange for the exchequer.

Shreeram Patel, Hon. Treasurer, TAAI highlighted and emphasised the importance of MOT being the one point of contact for all issues of travel trade and ensuring that other Ministries in the government support and encourage the fraternity to do business with ease.

TAAI National office bearers unanimously, in the Focus 2022 document, urged that these points must be jointly addressed to ensure that India leaps in the future to regain its past glory. ▲

# Increasing air bubble flight agreements with more countries will give much-needed impetus to business: TAAI



Soon after the Indian government signed yet another air bubble travel agreement with Australia, followed by signing the dotted lines with Saudi Arabia there are speculations and responses all around in the industry, mostly of which are positive, and the increasing agreements are being looked upon as some sigh of relief for the Indian aviation fraternity. After the latest agreement, direct flights between India and Saudi Arabia will commence soon, as the agreement will come into effect from January 1, 2022.

Speaking on the development, Jyoti Mayal, President, Travel Agents Association of India (TAAI) praised the government for taking a wise step in these times and expanding its air bubble flight agreement count for the betterment of travel and tourism sector and also the economy as a whole. "Such tough times call for an immediate action and I think this is the best that could be done to avoid travel difficulties to some extent," she commented.

With this agreement India has now an air bubble agreement with 34 countries including Afghanistan, Australia, Bahrain Kenya, Kuwait, Oman, Russia and so on.

Commenting on which Jay Bhatia, VP, TAAI said that this has come as a good sign, and it has not only expanded the horizons of international travel for Indian travellers but has also worked as an element strengthening bilateral bonds. "The government earlier had informed the Parliament that they have proposals from 10 countries to sign the air bubble agreements out of which Australia and Saudi Arabia have been accepted as of now and definitely more to follow," he said.

"Scheduled international passenger flight operations will remain suspended in India till January 31 meanwhile agreements like these could work as a catalyst in taking business forward which already has seen an avalanche of ups and downs during Covid crisis," Bettiah Lokesh, HSG, TAAI mentioned.

"Air Bubble agreements are one of the best solutions aimed at restarting commercial passenger services between the two countries when regular international flights are suspended due to Covid and the best part about these agreements is that they are reciprocal in nature which allows airlines from both the countries to enjoy similar benefits," stated Shreeram Patel, Treasurer, TAAI. ▲





# Domestic tourism gears up as international travel ban extended further: TAAI

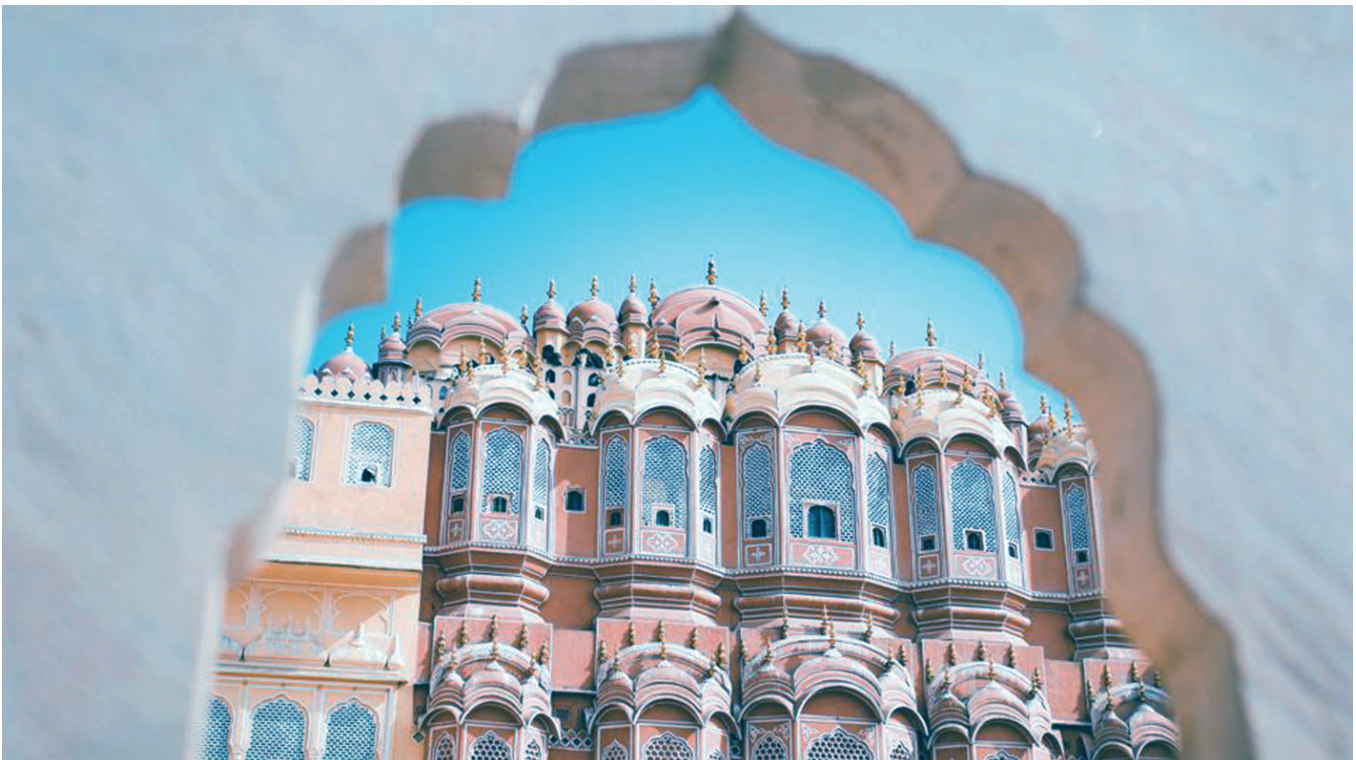
**A**midst the global crisis of COVID-19, many businesses have faced a rough patch and tour and travel industry to be specific, has faced a massive crash with rising number of cases across the globe. With current restrictions on scheduled international commercial flights, it was assumed that this might be the end of the business but as they say where there is a will there's a way. Air bubble flight agreements and domestic travel came to the rescue when all hopes from the international travel business were sinking.

Commenting on the situation and rising prospects for domestic tourism in the country, Jyoti Mayal, President, Travel Agents Association of India (TAAI) said that it might be a drop in the ocean but at least it is looking like a ray of hope coming from the clouds after a heavy storm. "States like Kerala, Goa and Rajasthan which were already hit among travellers, especially foreigners, are now domestic traveller's favourite go to destinations to beat the COVID stress," she said.

"People are aware of the situations very well now and also about the rising cases of new Omicron variant, but still they are preferring to step out mainly because they have become too homebound and secondly, they want to breathe the outside air before being homebound again if another lockdown happens" she further stated.

Governments of Kerala, Goa and Rajasthan have set the bars high for other states in terms of tourism as they have come up with fun filled activities like maiden water fest launched by Kerala Tourism and light and sound shows being set up at five tourist places to promote tourism in Rajasthan in order to engage local people in the whole event and also to boost tourism in the state. Likewise, the state of Goa has seen a huge footfall with the state having relaxed travelling rules. In order to keep this momentum under control, industry stakeholders have demanded a more relaxed tax regime, streamlining of GST and tax structures for travel agents and tour operators.

Appreciating the steps taken by the state governments to promote tourism in harmony with the economy by engaging local people in it, Mayal mentioned that is something worth noting and inspirational. "Many states other than these have also come up with new tourism structures like the homestays model in Uttarakhand, which is seen as a new way to revive the economy. With such innovative ideas coming forward, I would appeal to other state governments to follow the same pattern and be "vocal for local" in order to revive industry to some extent until international travel is not opening," she further added. ▲



# As an industry insider, it's always good to see the development of infrastructure for aviation to boost tourism: Jyoti Mayal



Prime Minister Narendra Modi will inaugurate the new terminal building of the Maharaja Bir Bikram International Airport in Agartala, Tripura on January 4, 2022. The new airport is built on a 30,000 sq meter area and will be able to handle 1,000 domestic and 200 international passengers daily. The airport is currently the second busiest airport in the Northeast region.

Extending her good wishes to the government, Jyoti Mayal, President, Travel Agents Association of India (TAAI) commented that these previous two years have been a roller coaster ride - unpredictable and shocking but news' like these works as a healer. "I have been in this industry for nearly four decades and as a veteran and industry insider, it's always good to see the development of infrastructure for the aviation sector, as tourism & travel and aviation go hand in hand and what happens in one place directly affects the other" she mentioned. Earlier the foundation stone of the Noida International Airport (NIA) in Jewar was placed last month in November, marking another achievement of the government in expanding the count of

airports in the country.

Union Civil Aviation Minister, Jyotiraditya Scindia and senior officials of the Airports Authority of India (AAI) would also be present at the programme. The new airport will house one hangar, six bays, 10 immigration counters, five customer counters, provision for link cabs and a bagging system in the new terminal.

"There are no questions when it comes to tourist spots in India, especially our northeast region offering heavenly nature and breath-taking sights. With such developments taking place in these regions, one could safely say that it would not only promote tourist footfall but also engage locals in employment which is a win-win situation for everyone," Mayal added.

The airport was first built as a military airstrip in 1942 on the land donated by the last ruler of the region and hence got its name. The airport currently managed by the AAI handles close to 5,000 passengers daily with close to 20 flights operating in and out of the airport. ▲





# People keen to travel even during risky times: TAAI

The rising risks associated with Covid-19's Omicron variant has not dissuaded holiday makers from their plans this season as 58 per cent of citizens still plan to travel during December to March period as per a latest survey. Commenting on which Jyoti Mayal, President, Travel Agents Association of India (TAAI) said that such enthusiasm from travellers has garnered a bag of mixed reactions. "While it is a good sign for the travel and tourism industry, it could also add to the already rising cases of COVID and its new variant and could potentially delay the process of revival. It is also a point worth noting that out of 58 per cent only 18 per cent of citizens have made their bookings so far. Whatever may be the case it is people's responsibility to follow all safety measures and the government's role to assure safe travel keeping in mind the economy along with people's health," she said.

"People have become too homebound during this pandemic that they are now kind of overlooking the risk and looking forward to step out in any way possible. This sounds promising if all the protocols and safety measures are followed properly," said Jay Bhatia, VP, TAAI.

Adding to which Bettaiah Lokesh, HSG, TAAI stated that a comparative analysis of the latest survey with the one conducted in March 2021 showed that the enthusiasm level



of citizens to travel despite the omicron threat is higher than what it was before Delta and the second wave.

"If travel is to continue, it is an absolute must that central and state governments and various authorities enforce the mask and social distancing compliance on the ground, things can get out of hand very quickly if the restrictions and enforcement is not paid attention to," mentioned Shreeram Patel, Treasurer TAAI. ▲

# 'No Vaccine, No Entry' a good step, will help sensitise public: TAAI

Haryana Government has made the second dose of Covid-19 vaccination mandatory for people to enter malls, restaurants, banks, offices and other public places starting January 1, 2022.

As soon as this statement was issued many eyebrows were raised and speculations were made as this was an apt decision taken or not; speaking on which Jyoti Mayal, President, TAAI said that it might be a good step in itself as it can create a sense of awareness and sensitize the general public about vaccination during COVID global pandemic. "Prohibiting entry for non-vaccinated people might prove to be helpful in containing the spread of this deadly pandemic and refraining such people entering into public places will prompt public to get fully vaccinated as early as possible fulfill their duty as citizen," she said.

Adding to which Jay Bhatia, VP, TAAI said, "Though the vaccination drive in the country is going on in full swing, there are still many areas to cover because of uneven distribution of the population and a large number of rural areas where health care facilities are not at par with urban areas. Such a rule might create inconvenience for people who are not



vaccinated and travelling for work. However, there is a need for uniform vaccination compulsion rule in all the states."

The Haryana guideline states that only fully vaccinated people will be allowed to travel from bus stands, railway stations and other places of gatherings like religious places, petrol and CNG stations, LPG gas cylinder collection centres, sugar mills, milk booths, ration shops also to allow only fully vaccinated people. "Such a decision could have a positive impact instead of the negative one. The decision sounds promising but considering the large number of population and availability of the vaccination slots especially in remote and rural areas might become a challenge but for the greater good, such steps are required," said Bettaiah Lokesh, HSG, TAAI.

"We all have seen the severity of this virus by now and how it affects us on so many levels. Vaccination plays a big role in decreasing its severity and avoiding deaths as much as possible. This move may turn out to be a successful one as the vaccination rate might increase significantly in the state," stated Shreeram Patel, Treasurer, TAAI. ▲

A closer look says that many travel agents and associations are now focussing on promoting travel the entire year rather than just focusing on seasons. This is the right step looking at the current situation and might prove to be a pragmatic step in the time to come.

With work from home being the new normal, people now have the luxury to travel throughout the year without waiting for particular seasons and vacations. This is a huge advantage for the industry and can be termed as a blessing in disguise. Apart from this, the concept of 'solo trip' is also gaining momentum and will surely add significantly to the emergence of the sector's health. The tourism industry is moving forward with all the necessary precautions and former experiences to tackle catastrophe if any. A massive decrease in the number of delta cases worldwide has surely provided a sigh of relief but the collective effort is necessary to keep things normal and in control. Lockdown crippled not just the economy but also the psychology of people all around the world who were forced to stay back at their homes to break the chain of corona spread. The tourism sector has significantly contributed not just in terms of just finances but also in the well being and happiness of people who always look up to travelling to beat their stress. This collective

chaos was seen as something unmanageable in the first three quarters of 2020.

Towards the end of 2020, as the number of cases started reducing, people who were stuck at home for more than nine months started going out. But now what mattered more was the hygiene and the crowd of the hotels rather than the complimentary breakfast menu and the location of the property. Corona scared people to the limit that they started paying attention to the minute details which were not even into consideration earlier.

Let's understand how the business was done in the tourism industry from December 2020 to March 2021. During that period Goa, Himachal Pradesh, Kashmir, Kerala, Andaman, the north-east region and Sikkim

had emerged as the most preferred destinations as most of these states had lifted travel restrictions. Many hotels and airlines did a brisk business. Of course, there was a scarcity of foreign tourists. What is important here, if we take the number of people vaccinated in that time and now, there is a huge difference and that is where the HOPE lies!

But as they say, there is dawn after every dusk. Hoteliers and travel agencies are not worried like last year because they have already seen the worst and now have backup plans in case there is a disaster like situation. But chances are slim for a disaster like situation.

Rather, the stakeholders in the industry are eagerly looking for scheduled international flights to resume. Aashish Gupta, Consulting CEO, FAITH, said, "The Indian Tourism Travel & Hospitality industry was eagerly looking forward to the resumption of international flights in December. Since March 2020 the inbound tourism has been shut and the flight's resumption as was earlier announced was one ray of hope. To salvage some business and have some cash flows to support tourism employment we look forward to a very early re-review of this decision of extension of flights if hopefully, the variant omicron doesn't pose a serious threat." According to him, Indian inbound earned almost \$ 30 bn pre-pandemic and October to March which is the main season was fully lost in 2020 half of this season lost in 2021.

Yes, resumption of international flight is necessary, once resumed, will address many issues of the travel & tourism industry, currently facing. Moreover, five lakh free e-visa being granted to tourists by



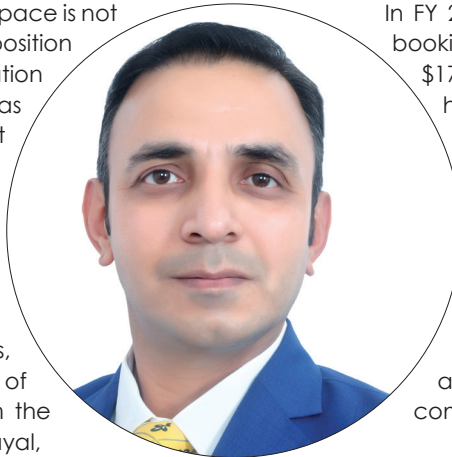

the government is meaningless if the airspace is not fully open. Today, India is in a far better position in terms of handling covid and vaccination of a large number of population has enhanced the image globally. Against this backdrop, the government should consider the early resumption of international flights. "India is a leader in sustaining and bringing the pandemic under control. Today, Indian travel trade, be it travel agents, tour operators, MiCE facilitators, Car Rentals, Hotels, Resorts or ground handlers, each one of them is geared to handle tourists from the world into India," pointed out Jyoti Mayal, President, TAAI.

The covid-19 pandemic may have slowed down India's travel and tourism sector, but a new report expects it to bounce back and cross USD 125 billion by 2026-27. According to 'Travel market in India' by RedCore, research firm RedSeer's arm, the travel business in pre-pandemic India was USD 75 billion in FY19-20. This will expand beyond USD 125 billion by FY2026-27, taking into account both domestic travel, inbound and outbound travel by Indians. This really augurs well for the industry and in all probability, the growth process will start soon.

The report also said the country's travel market is dominated by about 300,000 travel agents who represent the largest volumes of business in bookings at about 52% and the role of these agents significantly increased after the pandemic. This is certainly good news for all the associations, particularly TAAI (being the largest association).

In FY 2019-20, a majority of these agent-based bookings came from holiday packages worth \$17 billion, flights (\$10 billion) and standalone hotel bookings of \$5 billion. Cabs and intercity buses and railways contributed the remaining USD 6 billion.

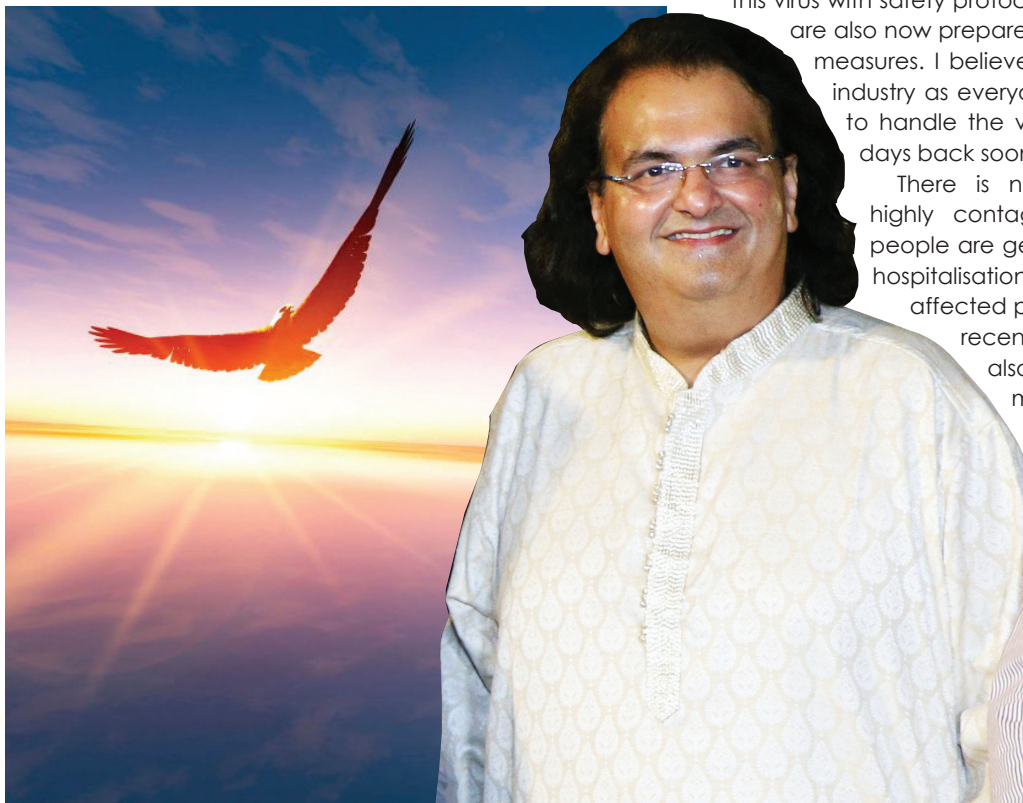
Agents are expected to add more than USD 65 billion to the travel market by FY26-27. "Travel in India is still heavily dependent on agents who people trust but also offer price competitiveness. They represent over half the travel market share and are expected to maintain this share in coming years," said RedCore.

According to the report, during covid, the uncertainties related to travel including tests, change of travel date, delay in travel due to restrictions motivated travellers to take the agent route for making the ticket booking.

No doubt, the growth of the industry will be led by domestic tourism followed by outbound and inbound sectors. By the time outbound and inbound sectors revive it is prudent to focus on the domestic sector. Jay Bhatia, Vice-President, TAAI, rightly pointed out, "Focusing efforts on encouraging domestic travellers to visit—and revisit—each destination; reinvigorating the workforce to enhance visitors' experiences; and reimagining India as a hub for business travel by keeping up to date with changing working norms." Echoing similar sentiment, Hemendra Singh Jadon, Chairman - TAAI M.P. & C.G. Chapter, said, "After the 2nd wave, we saw revenge tourism in domestic as well as international tourism (those countries which are open). I think now the travel industry is aware and ready to deal with this virus with safety protocols. Not only this, but travellers are also now prepared to travel by adopting safety measures. I believe now it should not affect our industry as everyone is familiar and knows how to handle the virus, hope to have our olden days back soon."

There is no denying that Omicron is highly contagious and more and more people are getting affected but the rate of hospitalisation is negligible in India and mostly affected people are asymptomatic. Two

recent studies released recently also indicated that the highly mutated Omicron is associated with a lower risk of Covid-19 hospitalisation when compared to the Delta variant. This is good news and people associated with the industry believe that it's a passing phase and soon the sector will come back to its original form. ▲

A delegation led by Travel Agents Association of India (TAAI) Gujarat Chapter office bearers along with National Managing Committee Member Mr. Paras Lakhia met Mr. Naved Desai, Airport Manager, Sardar Vallabhbhai Patel International Airport on October 20. They discussed various issues faced by travellers and submitted recommendations.

It was a fruitful, interactive discussion with Mr. Desai where they majorly discussed issues faced by travellers with respect to the mandatory RT-PCR test required for international travel. Destinations like Dubai mandates incoming passengers to get an RT-PCR test done before six hours of the flight departure but the lack of a proper system at the airport, travellers were facing some inconvenience and the issue which was taken up by the TAAI delegation.

The TAAI team suggested enforcing an advanced token system for the COVID-19 Rapid test for passengers travelling to Dubai. This system is very much in operation at Mumbai and Delhi airports. This will surely help passengers to plan as to how early they need to leave from home. It was suggested to at least start a token system for business class & first-class passengers or separate queue for them. The Airport Manager assured to look into the matter.

Other recommendations included giving airport resurfacing plans to a professional agency to avoid frequent closure of the runway, which badly affects travel schedules, especially during the festive season. The delegation also



suggested to Mr. Desai to form an Advisory Committee comprising representatives from the travel trade community as well, which can work as a bridge between the airport authority and travellers in communicating key updates about developments at the airport and also suggest solutions to problems faced by passengers.

The TAAI delegation further informed that they were apprised about the free of cost shuttle service operating between Terminal 1 and 2 of the Ahmedabad airport apart from the authority's plan to shift operations of some of the airlines from T1 to T2 to reduce the overburden of domestic traffic on one terminal. It was also revealed that major expansion will take place at the airport in a phased manner. ▲

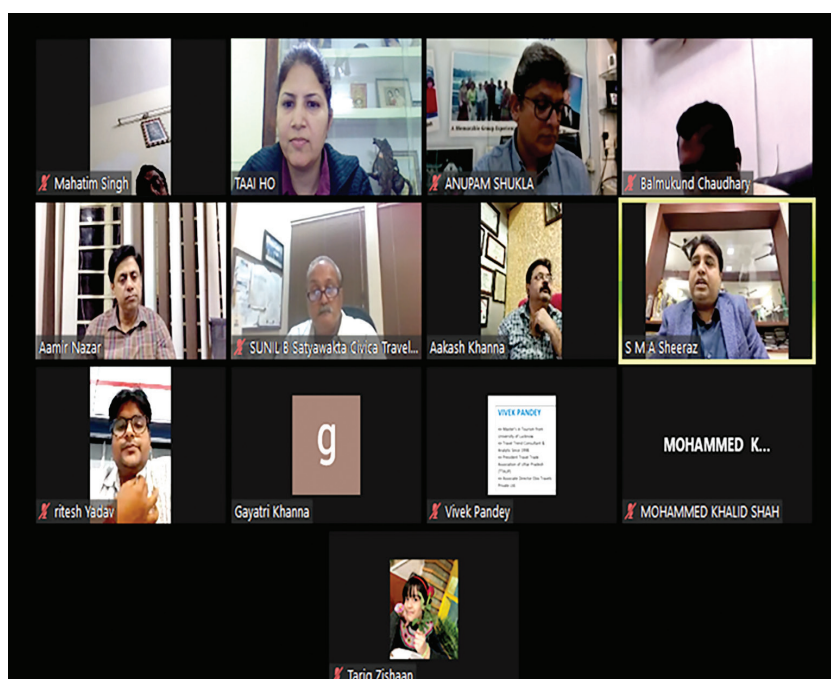



#### Another big tick on the list as Singapore & India reaches agreement on commercial flights: TAAI

Commenting on the proposed resumption of flights between India and Singapore from November 29 under the Vaccinated Travel Lane (VTL), Jyoti Mayal, President, Travel Agents Association of India (TAAI) extended her warm wishes and gratitude to the Civil Aviation Authority of Singapore (CAAS) and India's Ministry of Civil Aviation on the resumption of scheduled commercial flights between the two countries.

Singapore's VTL with India will start with six designated flights daily from Chennai, Delhi, and Mumbai. Applications for vaccinated travel passes for short-term and long-term pass holders from India will start from November 29. "Taking such a step in time of Covid prevalence is indeed a bold move which will not only strengthen the relations between the two countries but will also work as a revival of tourism sector". I strongly feel that more commercial flights are needed to revive inbound tourism to India," she further quoted.

Airlines can also operate non-VTL flights between the two countries, although passengers on non-VTL flights will be subjected to the prevailing public health requirements. "We at TAAI have been in constant dialogue with the Ministry of Civil Aviation, Government of India. The opening of the skies for international commercial passenger routes highlighting our concerns on ease of doing business," commented Jay Bhatia, Vice President, TAAI.

Taking positive efforts, TAAI Southern Region in association with the Singapore Tourism Board (STB) organised a travel webinar earlier this year in July which witnessed a large participation. "Such productive decisions are always welcomed by tourism sector and travel associations as the good part of the economy is dependent on travel and tourism. Economy everywhere needs a good revival especially after Covid trauma," Bettalah Lokesh, Hon Secretary General, TAAI.

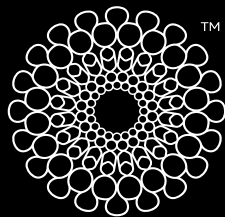

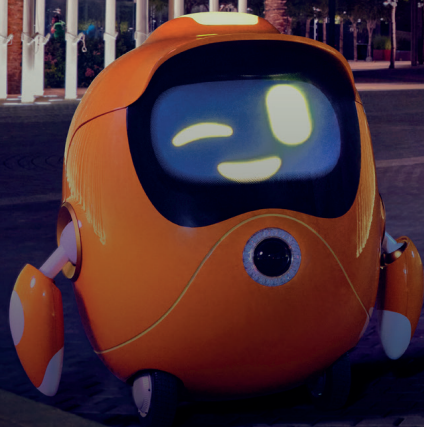

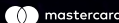
